- **Helped** our members to resist unlawful assessment of fees and discriminatory registration processes by certain states
- **Assisted** in ANI's defeat of Nevada before the 9th Circuit
- **Resulted** in multiple favorable decisions in response to our *amicus curiae* briefing challenging both regulator misconduct and state laws that violate the LRRA.
- **Produced** and supported the Risk Retention Modernization Act (HR-2126) in the Congress

- **Developed** a plan to address the California anti-"stop loss" initiative with the FIO
